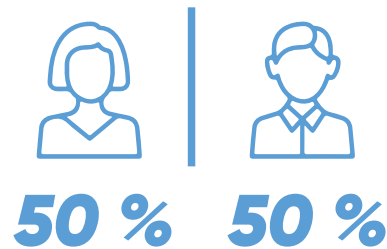
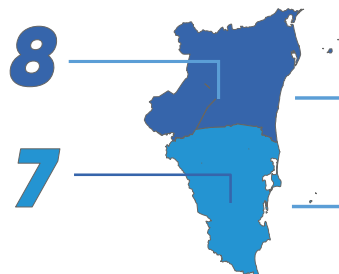
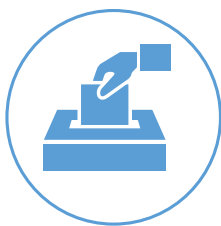


Political Organizations present candidacies for the election of the Members of the Regional Councils



In compliance with Article 69 of Law No. 331, Electoral Law and Activity Number 8 of the Electoral Calendar from January 15 to 22 of the current year, the Supreme Electoral Council developed the period for the provisional presentation of Candidates for the Councils Regional.

The list presented by the Political Parties and Alliances of Political Parties that participate in the "Victorious Elections Caribbean 2024", correspond to the 8 Municipalities of the Autonomous Region of the Southern Caribbean Coast and the 7 Municipalities of the Autonomous Region of the Caribbean Coast North.



The Supreme Electoral Council in accordance with Article 68, fourth paragraph of Law No. 331, Electoral Law, has ensured the application of the concept of alternation, requiring that the candidates be fifty percent (50%) women and fifty percent (50%) men, thus complying with gender equality in the 2024 Regional Elections to be held on March 3.

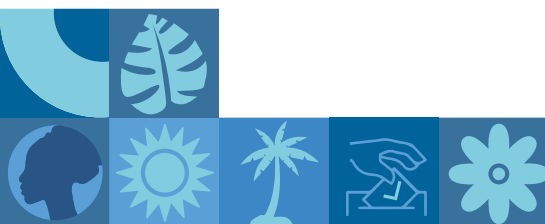
In compliance with the provisions of Article 69 of Law No. 331, Electoral Law and Activity Number 9 of the Electoral Calendar, once the presentation and provisional registration of Candidates for the Regional Councils was carried out, this Electoral Institution guaranteed that from January 23 to 29 of the current year, the period for the Correction, Resignations and Substitution referring to the 90 Candidates among Owners, with their respective Alternates for the Regional Councils, who will participate in the “Victorious Elections Caribbean 2024”.



Once the period of Correction, Resignation and Substitution has elapsed, the Supreme Electoral Council in accordance with Article 70, third paragraph, will order the provisional list of the 90 Candidates for the election of candidates to be published in The Gazette, official diary, the Members of the Regional Councils, Owners with their respective alternates.



All of the above so that the Political Organizations participating in the electoral process can challenge, within 72 hours from the date of publication, said candidacies. Once the aforementioned term has elapsed and no appeal has been filed or if the Supreme Electoral Council has filed a resolution, it will order the publication in the Gazette, official diary, of the definitive list of the Candidates who will participate to be elected in the Regional Elections 2024, next March 3 of the current year.



End of presentation of Shortlists by the Political Organizations for the integration of the Members of the Vote Receiving Boards

In accordance with Article 16 of Law No. 331, Electoral Law and Activity Number 19 of the Electoral Calendar, from January 19 to 24 of the current year, the period for presenting Shortlists by the Political Parties and Alliances was successfully developed of Political Parties to integrate the Members of the Vote Receiving Boards (VRB).



In the present electoral process, the Supreme Electoral Council (SEC) will operate 751 Vote Receiving Boards (VRB), in 308 Voting Centers (VC), so that the citizens of the Indigenous and Afro-descendant Peoples can exercise their constitutional right to vote, next March 3.



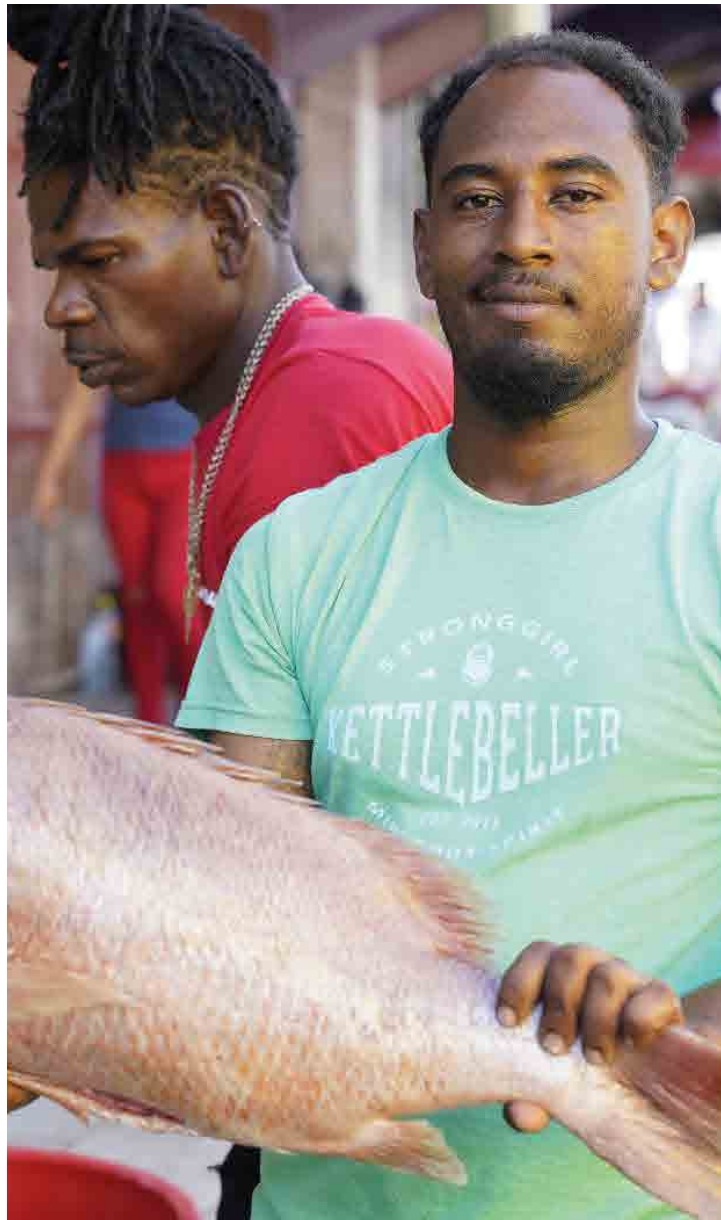

Each of the Vote Receiving Boards (VRB) will be made up of one or a President, one or a First Member and one or a Second Member, each and all with their respective substitutes who will provide support to the citizens of the Autonomous Regions of the North and South Caribbean Coast of Nicaragua in the 2024 Regional Elections.



SEC carries out training on the use of the Digital Platform for the registration of Prosecutors

In compliance with article 29, second paragraph, of Law No. 331, Electoral Law, the Supreme Electoral Council (SEC), making use of the new Information and Communication Technologies (ICT), on January 18 trained all and all the legal and technical representatives of Parties and Alliances of Political Parties, on the use of the Digital Platform for the Registration and Accreditation of the Prosecutors who will exercise their functions in 751 Vote Receiving Boards (VRB), for the current Regional Elections 2024.



This digital platform is designed with the objective of optimizing, ordering and streamlining the registration process of the Prosecutors of each of the political organizations.



For this Electoral Process, a total of 7,510 Prosecutors will be accredited, including Owners and Alternates. This digital platform is created to guarantee that the principle of Gender Equity and Alternability is complied with, in compliance with the provisions of Law No. 331, Electoral Law, which mandates the representation of 50% of women and 50% of men, in the lists of Prosecutors of each Political Organization.
