Period of Correction, Resignations and Substitution of Candidates for the integration of the Regional Councils concludes

The Supreme Electoral Council successfully completed the process of Correction, Resignations and Substitution of the Candidates to integrate the Regional Councils of the Autonomous Regions of the North and South Caribbean Coast, during the period from January 23 to 29 of the current year, thus complying with the provisions of article 69 of Law No. 331, Electoral Law and Activity No. 9 of the Electoral Calendar.

In these Victorious Elections Caribbean 2024, the citizens of the Indigenous and Afro-descendant Peoples will elect the 180 Members of the Regional Councils, between Owners and Alternates, of the 30 Electoral Districts, 15 Electoral Districts on the Northern Caribbean Coast, and 15 Electoral Districts on the South Caribbean Coast.

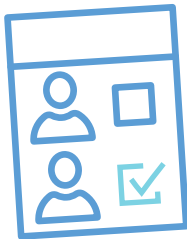

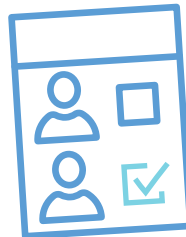
SEC develops period of Challenges



In accordance with article 70, third paragraph of Law No. 331, Electoral Law, the Supreme Electoral Council of Nicaragua, on February 1, ordered the publication in, The Gazette, official diary, of the Provisional List of the 90 Candidates with their alternates for the integration of the Regional Councils, thus beginning the period of challenges by the Political Organizations.

In that sense and in compliance with Activity No. 11 of the Electoral Calendar, from February 2 to 4, the Political Parties and Alliances of Political Parties participating in this 2024 Regional Electoral Process had the period to request the challenges that they considered pertinent on the candidacies for the integration of the Regional Councils.

This Power of the State guarantees in the list of candidates for the 2024 Regional Elections, compliance with Gender Equity and the concept of Alternation, stipulated in article 153 of Law No. 331, Electoral Law, which mandates equal participation to be elected and elected to elective positions of fifty percent (50%) of women and fifty percent (50%) of men.

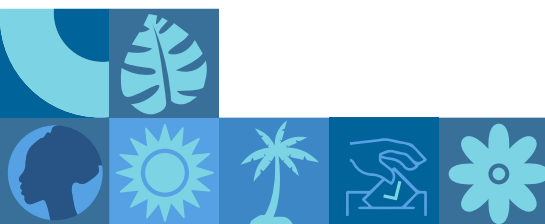

In accordance with articles 29, 30 and 32 of Law No. 331, Electoral Law, and in compliance with Activity No. 22 of the Electoral Calendar, the Political Parties and Alliances of Political Parties presented, on February 1, before the Supreme Electoral Council the list of proposals from citizens to be appointed as Owner and Alternate Prosecutors in the 751 Vote Receiving Boards (VRB) in the country.

This list is made up of 7,510 Prosecutors, including Owners, Owners and Substitutes, who will exercise their oversight functions in the 751 Vote Receiving Boards (VRB), which will operate in the present 2024 Regional Elections.

Ministry of the Interior calls for registration of Electoral Police for the 2024 Regional Elections








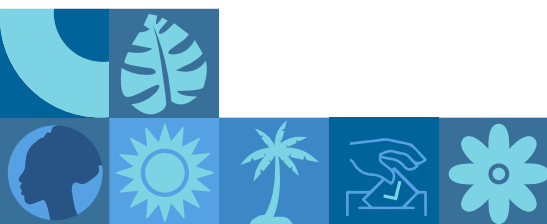
The Ministry of the Interior of the Republic of Nicaragua, between January 29 and February 9 of the current year, invites citizens who wish to participate in the responsibility of the Electoral Police in the 2024 Regional Elections to register this March 3.

In this sense, those who are interested in participating as Electoral Police must appear, between 8:00 am and 5:00 pm, at the Police Units that are located in the Autonomous Regions of the North and South Caribbean Coasts of Nicaragua.



Likewise, citizens who wish to participate as Electoral Police in the Victorious Caribbean Elections 2024 must meet the following requirements:

-  Being Nicaraguan
-  Legal Age
-  Literacy
-  Be physically and mentally fit
-  To have not criminal record
